- 1. I, the Releasor, understand that I will not receive any compensation or payment or any form of remuneration now or in the future in consideration for the above project.
- 2. The Producer will own any and all rights of the photography, recording or filming.
- 3. I hereby consent to the Producer, the Project Owner and/or their representatives, agents and related entities to Use my name, image or likeness in any photographs, films, videos, digital recordings or audio recordings of my Appearance for promotional, commercial, marketing or any other purpose whatsoever, whether or not accompanied by any narration or dialogue, by any present or future media or means known or unknown.
- 4. I waive all personal rights and objections to, including the right to inspect, any Use of my Appearance by the Producer in connection with the Project.
- 5. I understand that the Producer has relied upon my consent in allowing my participation in the Project.
- 6. I understand that the Producer reserves the right to issue or not issue me and/or my guardian(s) with the Material.
- 7. I and guardians waive all rights to inspect or approve the material and understand that the Producer will uses its own discretion in regards to the editing, filtering and releasing of each piece of Material.
- 8. I understand that should the Producer issue me with the Material, the Producer grants me permission to use the Material for my own personal or professional use, provided that:
  - a) I do not sell any part of the Material without the written permission of the Producer
  - b) The Producer retains all rights, copyrights and ownership to the Material and will be acknowledged as the owner and taker of the Material.
  - c) I understand that the Producer may issue the Material to the Project Owner and that the Project Owner may use the Material as deemed proper according to the Project Owner's own Terms and Conditions.

## 9. **Definitions**

- a) Releasor means the person signing this form and any guardians;
- b) Material means any photograph or video footage in which I appear, in any form, including but not limited to digital files, prints, discs and online material;
- c) Appearance means my name, image, physical likeness, voice, any and all attributes of my personality and/or performance;
- d) **Project Owner** means a person or business who engages the services of the Producer to take photographs or video for their personal needs or business requirements. If no Project Owner exists, the Producer will assume the role of the Project Owner
- e) Producer means:
  - i. Inview Studios and any successors, assigns or licensees; or
  - ii. the Storyteller and its assigns or licensees, as the case may be.
- f) **Project** means the digital story film created by the Producer and described above;
- g) Storyteller means an individual who owns copyright in the Project (in this instance the Storyteller is the Producer); and
- h) Use means lawful use and includes the exclusive and perpetual right of the Producer in any jurisdiction worldwide to:
  - i. use, copy, adapt and/or exploit;
  - ii. mix, edit, duplicate, or re-use, or create derivative works;
  - iii. assign, license or sub-license; and
  - iv. publicise and/or market;
  - exhibit and/or perform and/or distribute by any present or future media, for profit or otherwise, and for commercial or non-commercial use.
